Complainant: Chief Secretary

I am submitting the following documents and certain information along with this memo seeking adjournment of the hearing fixed on 14/3/2011.

I learnt from newspapers on 8/3/2011 that I have been posted as Officer on Special duty and ex officio Principal Secretary, DPAR (Departmental Enquiry Manual) that too when I myself is facing inquiry based on baseless charges. From that moment till yesterday afternoon many incidents happened and many information received by me clearly indicate that the latest transfer was not done with any good intention. As this time the ill motive behind my latest transfer is a conspiracy to show me as having committed

suicide even though murdered has made me very restless. My mental frame of mind because of this is totally unfit to examine any witness. To substantiate what the above, I am submitting the following documents:

1. Government notification dated 7/3/2011 appointing me as Officer on Special duty and ex officio Principal Secretary, DPAR (Departmental enquiry Manual) Page 891
2. My letter dated 8/3/2011 addressed to the Chief Secretary and others just before taking over charge as OSD & principal secretary , DPAR (Departmental Enquiry Manual ) and personally handed over to the Chief Secretary's office at 11.45 am on 8/3/2011 – Pages 892-894
3. Acknowledgment given on 12/3/2011 by the DG & IG of Karnataka Police for having received a sealed cover (H.E. the president of India is the only other person in the country who has been given those documents) - Page 895
4. Copy of complaint given against Sri SV Ranganath, IAS, Chief Secretary and others with the Cubbon park Police Station on 12/3/2011(partly masked) – carries seal of the police station .– Page 896-897
5. My leave application dated 12/3/2011 given to the Chief Secretary on the ground of serious apprehension of threat to life – carries seal of the Chief Secretary.- Page 898-899
6. Availability of circumstantial and direct evidences to show that the Chief Secretaries since 2007 with criminal intention created records to show that they doubted my mental health Pages 900
7. Availability of circumstantial and direct evidences to show that the Chief Secretaries since 2007 deliberately delayed holding enquiry with criminal

intention even though I submitted my response to charges in Dec 2007 itself. Pages 901-903

8. Availability of circumstantial and other evidences to show that the location of my office has been deliberately so chosen on the 21<sup>st</sup> floor of the building with wide windows that after killing me my death would be made to appear as suicide by a mentally ill officer of having jumped from the window. I also learnt that the fact that Inquiry Authority and Consultant Justice Sri MP Chinnappa had recorded that during my examination I wept would be used to convince that it is not murder but suicide. Sri Richard Lobo, Presenting Officer may also give evidence to the effect that recently I have been showing frequently signs of mental illness. My own written admissions of having suffered temporary mental breakdowns due to unbearable harassments and humiliations would also be used to project the murder as suicide. It is very important for me to continue with the Inquiry and examine and expose the witnesses who have refused to give evidence. If I do not take precaution, then my entire fight against corruption for last 30 years would go waste and my plan to intensify the fight against corruption immediately after the conclusion of the Inquiry would not be possible. My wife instead of fighting corruption would be kept busy fighting for justice to show that it was murder and not suicide.

Details of malafide intentions behind locating the office in the present place is given at Pages 904-905

9. Grounds to highlight the facts that examination of witnesses cited by me are very important to bring out many criminal conspiracy behind my continuous harassment and in particular to know the identity of persons who have been alleged to have accompanied my wife and me on 23/5/2007 and to establish that the officers who have recorded some people accompanied us also know the real identity of the people who have

made the alleged recording of the conversation . Page 906-907.

10. A copy of complaint dated 12/3/2011 given to various authorities by my wife Mrs Jayashree JN(whose examination as a witness is still going on). In her complaint she has stated that if the location of the office is not changed to a safer place, she would publicly protest till it is changed. Page 908

### Prayer

My frame of mind in view of the above developments does not permit me to continue to examine my witness. I request the Inquiry Authority and Consultant to adjourn the hearing fixed on 14/3/2011 and fix the next date of hearing only after the following decisions are taken

1. The Inquiry Authority & Consultant requested to write as per the Government of Karnataka instructions vide OM No.GAD(OM)3 CAR 57 which is reproduced in the Compendium of Government Orders (compiled till 9/2/2005), to the concerned officers to produce the important documents sought by me which have not been produced till today. As per the same OM, he is also requested to write to the witnesses listed by me to appear and give evidence. If there is no response from the officers to produce documents and the witnesses fail to appear, then I request the Inquiry Authority and Consultant to seek authorization from the Disciplinary Authority regarding production of documents and to enforce witnesses as per the Enforcement of attendance of witnesses, production of documents... Act, 1981. I am making these requests as it is the responsibility of the Inquiry Authority to conduct fair inquiry. I will continue examination of my wife only after examining all other witnesses who may appear as informed in December 2007 itself.


2. After the Chief Secretary shifts the location of my present office in consultation with the police for the reasons given by me to the DG and IG of Police. To give enough time I have applied leave till 26/3/2011. If the place of my work is not shifted then I would be extending leave till it is shifted.
