Sub: Demanding Shri Kaushik Mukherjee to place this letter along with my letter dated 22nd Nov 2014 before the Hon'ble Chief Minister and the State Cabinet to entrust criminal harassments to me to the CBI as I have received reliable information from a Secretary to GOI about the impending serious threats to my life immediately after retirement and particularly when the police failed to act on any of my complaints since 2006 and in the light of the death of Shri D K Ravi, IAS.

Ref: 1. My letter addressed to the Hon'ble Chief justice of Supreme Court Shri H L Dattu enclosing this letter and a copy of my letter dated 22nd Nov 2014 to direct the CBI to take up the investigation of the death of Shri D K Ravi and also entrust to the CBI the criminal harassments (including attempts on my live while under police protection) I have been facing from the corrupt IAS mafia since 2006

2. Suicide (??) of Shri D K Ravi, IAS reported in media yesterday and today
3. My innumerable reports given to various authorities since 2005 about the corrupt activities of senior IAS officers
4. Complaints given by me and my wife to the police since 2006 regarding threats/attempts on my family members and me
5. My email dated 13th March 2015 addressed to some IAS officers after I received on 12th March 2015 some shocking information indirectly from a Secretary to GOI
6. The Whistleblowers Protection Act

Dear Shri Kaushik Mukherjee,

Though I had written most portion of this letter yesterday itself before the news about the death of Shri D K Ravi, IAS broke out, being aware of the fact that the biggest mafia in the country is run by the corrupt IAS officers, in addition to demanding entrusting the investigation of the death of Shri D K Ravi to the CBI, I also demand that you immediately place this letter before the State Cabinet so that all criminal harassments meted out to me (including attempts on my life) since 2006 are entrusted to the CBI for immediate investigations for reasons given in this

letter. The information given in this letter brings out unequivocally the total failure on the part of the police in Karnataka on acting properly on any of my complaints given to the police since 2006. I do not have to elaborate that this was done to protect corrupt officers like you. As the extensive documentation available in both the GOI and the GOK indicate I have been criminally harassed since 2006 for refusing to compromise with corruption as demanded by the Chief Secretaries since I have been reporting serious corrupt and criminal activities of corrupt IAS officers to various authorities in GOI and GOK.

In spite of knowing the total uselessness of writing any such letter to officers like you, I decided to write this in view of the information received from a Secretary to GOI on 12th March 2015 warning me to be extremely careful about impending serious threats to my life and to hold you and others directly responsible if anything happens to me. But I want to inform you that such threats from the corrupt IAS mafia have further strengthened my resolve to fight the corrupt even more vigorously after retiring from Service.

In spite of this I want to immensely thank the corrupt IAS mafia headed presently by you in advance for creating a situation and giving me an opportunity to go to the Press by your shameful actions which would certainly help me promote in larger public interest what I have been doing risking my life since 2006. I did what I did being fully aware of the fact that, had I agreed to what Shri SV.Ranganath, the then Chief Secretary told me on 26th Oct 2009, I would have most probably today become the Chief Secretary myself, in addition to getting illegal money of a few hundred crores. But all that ill-gotten money would have made me like you to be worried all the time about when I would be sent behind the bars. With my firm opposition in writing to the frequent demands of the corrupt IAS mafia to compromise with corruption, unlike you, I stand tall today though unfortunately it has been at the cost of my career. It is unfortunate that the corrupt IAS mafia as informed to all IAS officers by me on 21st Feb 2011, had to even stoop to the level of bribing a Consultant to get the predetermined findings to harass me.

I did not stop my fight against the corrupt IAS mafia even after the massive lightning speed futile operation by the corrupt IAS mafia headed by you. This is exhaustively documented in my letter dated 22nd Nov 2014 addressed to the Hon'ble Chief Minister. Since January 2010, Dr SK Sarkar (who retired as the Secretary, DoPT in July 2014) was fully aware of how I am being continuously criminally harassed for my fight against the corrupt senior IAS officers since 2006. In fact, he was a totally helpless witness to many criminal conspiracies hatched by Shri SV Ranganath, former Chief Secretary from Jan 2010 till he retired from Service in Oct 2013. But Dr SK Sarkar never allowed the corrupt IAS mafia to use the DoPT directly. The

message I received on 12th March 2015 (ref 2) indirectly from a Secretary to GOI indicates that things have drastically changed since February 2015 and that risk to my life has increased abnormally high. As an IAS officer who has been working for 34 years at various levels, no one should underestimate my capacity to understand how systems work at various levels including Government of India. In fact, the change in the way I mark copies to DoPT after Dr SK Sarkar retired reflects my grasp of the fact that DoPT no longer bothers about my safety in any manner. To hold those who are now criminally conspiring to finish me off using every method, it has become important to place certain facts which happened in 2007 as those appear to be happening again.

I can understand the disappointments that corrupt officers like you must be feeling after all criminal conspiracies to get me murdered while I am still in service failed. As you have also amply demonstrated with your innumerable criminal acts, the post I hold today (that too by creating a new unsafe office) was never intended to get any Manual prepared but was created with a view to somehow get me killed (In fact the approval of the then Chief Minister taken was ignored to give me this post). On 8th March 2011 itself, someone in the Chief Secretary's office tipped me about such a criminal conspiracy when I was waiting in the Chief Secretary's office to know the location of the newly created office. **I was told that corrupt IAS officers who were criminally conspiring against me to get me killed but failed, wanted the office so located that it becomes easy to push me from the 21st Floor of the VV Towers and show it as suicide.** On 11th March 2011, I filed a complaint with the police after getting some more information from others confirming such a criminal conspiracy to get me killed (For nearly two years all my complaints given to the police were ignored. **Shri S P B. Singh**, DCP, who visited my office in January 2013 was fully aware of this- He did not allow me to even use lift without police escort but after his visit he was transferred and **Shri L Singh**, DCP contacted me only once and did not respond to any of my subsequent letters after getting information in writing from me on 19th Feb 2014). Dr. SK. Sarkar, DoPT since 2010 in his various capacities in DoPT including as Secretary, DoPT was fully aware of attempts on my life as he used to get information from one Dr. **D Yadav** who was in touch with my wife and me. Unfortunately the silence on the part of Dr SK Sarkar to my various queries indicate that **Dr D Yadav** who was reporting about our safety to the Hon'ble Supreme Court and H.E the President of India was himself murdered (If he were alive he would have responded to letters sent by me directly to him).

I want to give some information about what happened since 2007. On 12th March 2007, a police officer visited my house and asked me to carry fire arm for my protection after learning that I was posted to Mysore Lamps and was not provided any staff, vehicle or phone. He took written statements from me and my wife about an attempt made in June 2006 to kill me. After

a few days an Intelligence Bureau officer visited our house. Dr SK Sarkar was aware of the security arrangements made by **Shri Sridhara Murthy, SP (Intelligence Bureau)** to safeguard my wife when I was forcefully sent to Belgaum in 2007. The then Chief Secretary Shri. P.B. Mahishi forced me to report to Belgaum with the sole intention of getting me murdered there ignoring the assurance given by the then Chief Minister through the media. Dr SK Sarkar was also aware of the fact that **Smt Sharada Subramaniam**, then Secretary to the Governor of Karnataka was aware of how **Shri Sridhara Murthy SP (Intelligence Bureau)** used to collect materials about corrupt activities of Shri P B Mahishi sent by various well-wishers to my wife which were finally used to throw out Shri P B Mahishi from the post of Chief Secretary. On 6/8/2007, on the day after I took charge in Belgaum, **Shri Ganga Reddy, DyDP**, Khade Bazaar Police Station called on me and made it clear that the situation was very serious and warned me to be careful and not to trust anybody. Many efforts were made to pull me out of my secured place in Belgaum on the pretext of Meetings etc. Because of the tip off which I had shared with the then Principal Secretary, WRD Shri AKM Nayak (who masterminded my transfer to Belgaum) I was able to survive. If the Belgaum police had pursued the sudden appearance/disappearance of **Shri L N Nayak SP (Intelligence)** on 11th Sep 2007 (who showed me his identity card – revealing that he was also an officer of the Intelligence) who warned me to leave the Guest house as supari had been given by some IAS officers to get me killed, then the attempt on my life even while under police protection could not have happened on 4th Nov 2007 or 17th Nov 2007 or on 28th Dec 2007 or on 2nd Feb 2008. Many senior officers in the government knew the fact that how **Shri Sridhara Murthy SP (Intelligence Bureau)** and **Shri Syed Riaz, SP(Lokayukta)** had to force **Shri R Auradkar, when he was IGP(Belgaum)** to make proper arrangements for my safety after two attempts were made on my life while I was under so called police protection. It was only after pressure from those two police officers that **Shri Hemanth Nimbalkar**, the then SP, Belgaum by his letter dated 24th April 2008 informed me and my wife that it is the Government which had to take decision entrusting the investigation to the CBI. Though I wrote to the Government and also to the CBI directly nothing happened.

I had informed the government in 2006 itself that I would be extensively documenting not only my efforts to fight corruption but also the harassments that would be meted out to me by my corrupt seniors. As the above criminal conspiracies were frequently resorted to by the corrupt IAS mafia at the documentation stage itself (many of these have already been brought to the notice of both GOI and GOK), then what awaits me once I retire from the Service and start pursuing innumerable criminal cases against the corrupt IAS mafia I have since 2010 reported to various authorities made me to write this letter.

Later **Dr D Yadav** was reporting such matters about threats to us not only to the Cabinet Secretary, the CVC but also to the Hon'ble Supreme Court and even H. E. the President of India (**Dr D Yadav** used to mark copies to my wife and me all information he was sending to those authorities. I have copies of all such letters) Dr SK Sarkar knew much before my inquiry concluded that **Shri SV.Ranganath** had bribed a Consultant to get a predetermined report to punish me as many conspiracies to murder me had already failed because of tips given to me by someone in Chief Secretary's office more than thrice. Obtaining such a false report was possible by massive suppression/distortion of facts, destruction of documents and even forgery. In fact my letter dated 11th March 2015 addressed to the Secretary, MHA in a way reveals not only who helped those who wanted me dead in 2007 but also why no investigation was done in spite of two attempts on my life were carried out while I was under so called police protection.

It appears the same reason is there behind not even registering an FIR based on my complaint given to the Police on 11th March 2011 and other subsequent complaints. **Shri ST Ramesh**, then DG & IGP in April 2011 had asked **Shri Om Prakash** (who is today IG & DGP) to inquire into my complaint dated 11th March 2011 (this was also reported in a newspaper). **Shri Om Prakash** did not act. I again pursued the matter with **Shri AR Infant** after he became DG & IGP. Not only he responded in writing but he told me in person in the presence of witnesses about other criminal activities of the then Chief Secretary, **Shri SV Ranganath** and informed me that he has directed his officers to act on my complaint. By this time **Shri L Pachau** became the DG & IGP. I again pursued the matter with him. When he also failed to act on my complaints since 11th March 2011, I filed complaint against Shri L Pachau himself with the **Police Complaint Authority** In view of the nature of my complaint, the **Police Complaint Authority** referred my case to **Shri SK Pattanayak, IAS, ACS, Home Department** and **Shri SK Pattanayak** has kept that case without taking any action to protect all those involved in the conspiracy to murder me. The same must be true in respect of my complaint given to the Police of 24th Nov 2014 as **Shri Sidde Gowda, sub Inspector**, MS Building Police Station after speaking to me over phone in the first week of Feb 2015 so far has not contacted me again after informing me that he would get instructions from his senior. **Shri Om Prakash** who did not act on the instructions of his DG and IGP in April 2011, has now himself become the DG and IGP, and I cannot expect him to act now properly as his own serious lapses would be exposed.

I have repeatedly informed you that I already have permission to criminally prosecute you and other senior IAS officers under the Prevention of Corruption Act (which the DoPT has never contradicted till today). I have extensively documented, reported and complained to various

authorities including the Police against all officers in DPAR for repeatedly criminally obstructing me to prevent me from discharging my present official duties with the sole view of covering up their own and others' corrupt and criminal acts. Even an ordinary citizen who reads my letter dated 22 Nov 2014 would easily understand how many senior IAS officers criminally conspired to save one of their own kind.

It is under such an obnoxious and vicious situation, I made up my mind to write this letter. The death of **Shri D K Ravi, IAS** has made me to reveal the names of police officers who are deliberately choosing not to act though they are aware that I am using abnormal methods to stay alive. In a way, my case is as bad as a gang rape victim forced to approach the very rapists who raped her for justice. Since I am forced to face a similar situation to write to the very officers who want me dead, like the verdict by the gang rapists is predetermined, I am fully aware of what the corrupt IAS mafia would do. However, the present post I hold demands me to address even such horrible issues which allows honest officers being recklessly harassed by the corrupt officers while corrupt officers not only receive protection but also get promoted.

This becomes important to expose the methodology used to silence the honest to loot public wealth and money by the corrupt in the government. Criminally harassing an IAS officer for his continuous effort to uphold core values of his Service is not just a mockery of the core values but a shamelessly brazen effort to allow the corrupt to loot public money and property. As far as I am concerned, the biggest satisfaction I have is to be alive after such exhaustive documentation of the functioning of the corrupt IAS mafia and reporting them to those authorities in the country who are vested with power to take action. While the corrupt IAS mafia wants to send a message that no honest IAS officer in the entire country should ever remotely follow my methodology to expose the corrupt IAS mafia, through this letter I want to give some ideas to honest officers to fight corruption without being harassed. Unfortunately, **Shri. D.K.Ravi** though received letters from me did not prepare himself appropriately, physically, psychologically, strategically etc. **If the State Cabinet fails to take action to entrust Shri D,K,Ravi's death and harassments meted out to me since 2006 , then I will would be making this letter available to the citizens to make them understand the fact that our country getting branded as one of most corrupt countries in the world year after year is because of the deliberate abdication of duties by those officers who are vested with the responsibility, as custodians of public wealth, to prevent and contain such corrupt activities.** If a senior officer like me that too tasked with the job of writing a Manual to prevent dishonest from escaping punishment can be treated so inhumanly and in totally barbaric manner by the corrupt IAS mafia, then the plight of the honest officials at very junior level should not be difficult to understand. In fact, as

I have come across, many honest officials at junior levels do not even understand that how their corrupt bosses always shamelessly manipulate systems and evidences to harass them. No wonder that such brazen efforts even drive many to leave the Service while some even take the extreme step of taking away their own lives. If an official is extremely strong willed like me, then the IAS mafia does not even hesitate to get them killed. All these have been also documented by me. Ultimately, I am sure that the corrupt IAS mafia is going to celebrate the triumph of trampling the truth if I am finished in any manner, but I am proud to state that the combined efforts of the corrupt IAS mafia totally failed to make even a dent to my spirit of fighting corruption.

In view of the extreme danger to my life awaiting from the corrupt IAS mafia headed by you to me even after retirement from Service and particularly in the light of warning sent to be extremely cautious from a Secretary to GOI, I demand you to place this letter along with my letter dated 22nd Nov 2014 addressed to the Hon'ble Chief Minister immediately before Hon'ble Chief Minister and the State Cabinet. Considering the total failure of the State police to act on any of my complaints since 2006, it is important to entrust the investigation of criminal harassments I am subjected since 2006 for refusing to compromise with corruption to the CBI. I want the State Cabinet to take a decision to immediately entrust it to the CBI to protect my life. This becomes all the more important as I was the only IAS officer in the entire country to have given evidence (both oral and documentary) before the Parliamentary Committee which examined the Whistleblower's Protection Bill. Most of my suggestions were accepted by the Standing Committee. Please do not suppress the fact from the State Cabinet that I have sent a copy of this letter along with my letter dated 22nd Nov 2014 to the Hon'ble Chief Justice of India Shri H L Dattu. If the State Cabinet does not entrust my case to the CBI within a week's time, then, to save my life I will be left with no choice than to make this letter public. I would also be sending a copy of this letter along with a copy of my letter dated 22nd Nov 2014 to the Hon'ble Chief Justice of Karnataka High Court Shri D H Wagela requesting him also to entrust to the CBI not only the death of Shri D K Ravi but also extreme criminal harassments including attempts on my life as Karnataka Police totally did not act on any of my complaints since 2006.
