When I saw the document sent by you today morning (I have attached the document sent by you to this mail again) and read it, the only thing that came to my mind was that someone is joking!

But when I read that this is done under the Authority of H.E. the President of India, I am compelled to provide a feedback - particularly since my name has been prominently mentioned in the document and facts are distorted.

Regarding the rest of the write-up, it appears to be written without application of mind. The document seems to be a fumble rule or a self-referential paradox for the reform of administration. Though it claims to advocate a new solution to the problems that plague the system today, this communique repeats the problems it tries to address. The write-up is steeped in mistakes, obscure sentences, unknown acronyms and obnoxiously grandiose clauses. The exact agenda or the objective of the endeavour is unclear. There is no mechanism proposed by which the various members may share ideas. **It is very hard to believe that such a document has been approved by eminent personalities of India**

If H.E. the President of India had not been the Authority and the Hon'ble Supreme Court of India had not been the adviser for this group, I would have sincerely urged the "Mentors" and the "Advisers" of this group to reconsider their affiliation with this group. I would also have remarked that this document appears to be the work of someone aspiring to be the next Humphrey Applebee, without the necessary skills in language or cognition. Further I would not have hesitated to mention that this combination was not only useless towards real progress but was in fact detrimental. Because of the involvement of very eminent personalities, I suggest that you take back this material to those who have approved such a material to reconsider the absurd statements therein and clearly restate the Mission, the Objectives and the Mode of reaching those objectives and defining clearly the role and responsibilities of each one in the Group. Regarding the motto "Performing Honesty": I personally feel that honesty is something which you demand of yourself and not because someone else wants it performed as an obligation. It is not clear if this is a call for everyone to put on a performance of honesty or to perform honestly. Hence the motto seems to be improperly coined and incomplete.

I have made the above comments as a *mentor* and not with any ill will. I request you to take them in good spirit. We should all work together for a better India. Luckily technologies available today make such a thing possible in a very short time.
