today morning itself.

In continuation of my email giving phone number , I want the person whom you will be sending to collect the Enquiry file to bring three sets of printed copies of the list enclosed to this attachment which gives page number on each reference as it appears that there is some alignment problem with my 18/1/07 listing of documents and also because of cut and paste work done by me certain dates are repeated wrongly.. **All the corrections and additions are shown in bold**. Please ask the person to speak to me today only to get route to my house. **Please instruct him to verify the documents thoroughly as I had prepared the listings when I was under tremendous pressure and fear. My entire family even today is under threat, We have lodged three complaints during the last one month period some very serious in nature (including an attempt to enter the house by a stranger when my son was alone). Because of such incidents I am forced to take all these precautions.**

He should bring the following without fail by 10 am on 19/12/07. I will not be there after 12 noon

1. A letter authorising him to collect the file
2. A letter of introduction and attestation of his signature by you.
3. Two copies of my covering letter dated 18/1/07 which contains 5 points
4. Three copies each of listings - both the old one sent on 18/1/07 and the one sent today with this mail
